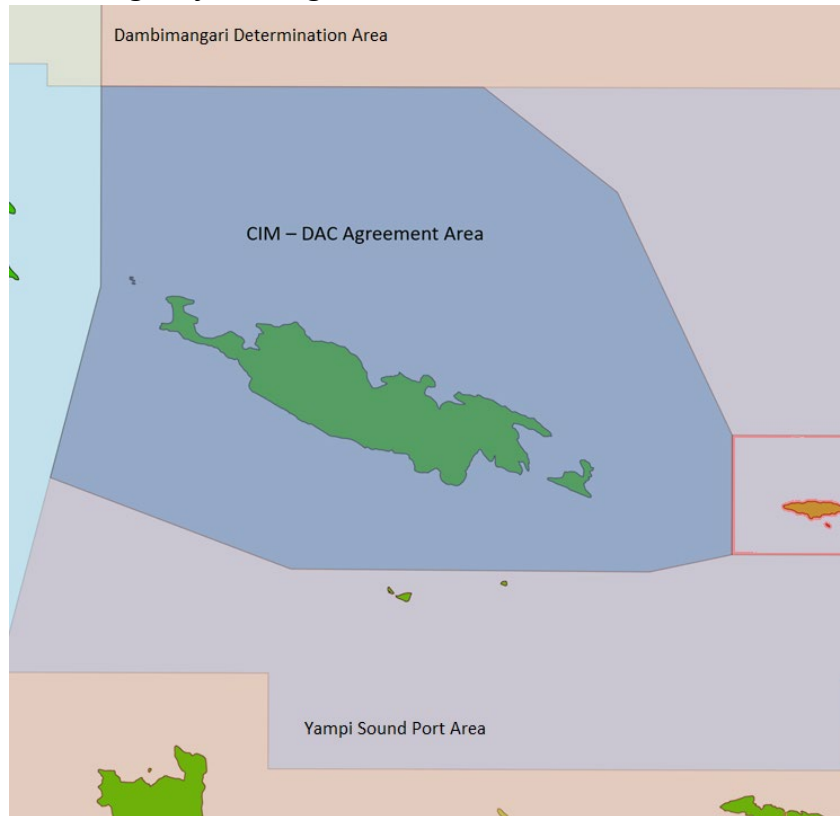
### Cockatoo Island Co-Existence Indigenous Land Use Agreement with Cockatoo Island Mining Pty Ltd
