



Terms and conditions of the Dambimangari Visitor Pass (DVP) 2025

You acknowledge and agree that:

1. Your Dambimangari Visitor Pass (DVP), issued by the Dambimangari Aboriginal Corporation (DAC), is not transferable in any circumstance to any other person or to a later date, will not be refunded for any reason nor can any portion be held in credit for later use.
2. Your DVP provides Dambeemangarddee people's consent to visit the Approved Visitor Locations within Dambeemangarddee country. Visitation to locations not included on the Visitor Location Schedule will result in legal action to enforce the rights of the Dambeemangarddee People as Native Title holders.
3. If you wish to access an Aboriginal Reserve (e.g., Kunmunya or Wotjalum) you must also obtain a Transit Permit from the Aboriginal Lands Trust. That requirement is in addition to obtaining your DVP from DAC.
4. You are only permitted to access approved visitor sites for the period stated on your pass.
5. You must carry your DVP and the ALT Transit Permit (where required) at all times and produce or display for inspection by a Dambimangari Ranger if requested.
6. If you are a tour operator you must hold the required number of DVPs for the number of passengers aboard your vessel, regardless of the number of passengers on any specific land access.
7. You must stay on Visitor Location access tracks and keep within 200 metres of an approved Visitor Location.
8. You must not land a helicopter anywhere on Dambimangari Native Title land without a DAC helicopter landing permit.
9. Dambeemangarddee country is a remote natural environment with unpredictable conditions. It is a DVP condition that you acknowledge and accept that your entry and stay on Dambeemangarddee Country is entirely at your own risk. DAC shall not be under any liability of any kind whatsoever, whether in negligence, breach of statutory duty or otherwise, in respect of death, injury, loss or damage to person or property howsoever arising, which occurs at any time whilst accessing, travelling through, or staying upon any part of Dambeemangarddee Country.
10. You must follow our Dambimangari Visitors Code of Conduct.
11. Commercial filming - You are not permitted to take photographs, film or reproduce images in any media form for commercial purposes or media sharing platforms, without first obtaining written permission from DAC. For the avoidance of doubt this includes uploading images to Business pages of Facebook, Twitter, Instagram, commercial webpages or any other media sharing platform. Contact media@dambi.org.au
12. DAC reserves the right to cancel a DVP for breach of Terms and Conditions. Such persons are no longer welcome and must immediately vacate Dambeemangarddee country.
